MEDHOST Enterprise electronically identifies for a user patient-specific education resources based on data included in the patient's problem list, medication list, and laboratory tests and values/results. Customers may chose to use the Info-button feature, which pulls content from the National Library of Medicine. And/or customers may choose ExitCare Complete - ExitCare Complete Discharge Planning includes one annual single site Inpatient license (in all languages), as well as licensing for Emergency Department, ExitMeds, Drug-to-Drug and Allergy-to-Drug Interactions, Patient Medication Schedule, ExitLabs, and "OPE" Patient Comprehension Questions. Transition of Care	Allows the EHR user to receive, display, incorporate, create and transmit a transition of care/referral summaries. A connection fee will be charged to establish a connection to each third-party HISP with whom MEDHOST currently has no relationship. Clinical Quality Measures	Enable users of EHR to capture, import, calculate and report on electronic clinical quality measures.	MEDHOST Enterprise solution requires the purchase of MEDHOST Business Intelligence to calculate and report electronic clinical quality measures. CQM data is captured and sent to MEDHOST Business Intelligence upon patient discharge. If collection of this data is found to be deficient due to improper build of enterprise assessment forms or mappings to proper vocabularies, an additional fee for reprocessing corrected cqm data captured on EHR systems may apply. Multi-facility or provider fees may apply.
